**AN ORDINANCE
AMENDING THE CITY OF READING CODE SECTION 576-207,
ONE-WAY ROADWAYS ESTABLISHED**

WHEREAS, the Administration continues to seek available means to create more parking for City Residents; and

WHEREAS, the Administration has determined that the establishment of one-way traffic on Cotton Street and South Street will create more available parking; and

WHEREAS, the Administration therefore requests the within amendment to establish one-way traffic on Cotton Street and South Street.

NOW, BE IT HEREBY ORDAINED BY THE CITY OF READING CITY COUNCIL AS FOLLOWS:

Section One: The City of Reading hereby amends City of Reading Code Section 576-207, One-way Roadways Established pursuant to the attached as Exhibit "A."

Section Two: All relevant ordinances, regulations and policies of the City of Reading, Pennsylvania not amended per the attached shall remain in full force and effect.

Section Three: If any section, subsection, sentence or clause of this ordinance is held, for any reason, to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance.

Section Four: This Ordinance shall become effective ten (10) days after its adoption in accordance with 219 and 221 of the Home Rule Charter of the City of Reading.

EXHIBIT "A"

1. § 576-207. One-way roadways established.

A. The following are established as one-way roadways, and it shall be unlawful for any person to drive a vehicle on any one-way street other than in the direction established for traffic on that street:

Street	From	To	Direction of Travel
East Wyomissing Boulevard	Lancaster Avenue	Brookline Street	Northbound
Klein Avenue	Seventeenth Street	Eighteenth Street	Eastbound
South Fourteenth Street	Perkiomen Avenue	Muhlenberg Street	Southbound
<i>Cotton Street</i>	<i>South Nineteenth Street</i>	<i>South Nineth Street</i>	<i>Westbound</i>
<i>South Street</i>	<i>South Nineth Street</i>	<i>South Thirteenth Street</i>	<i>Eastbound</i>

B. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

C. On-street parking shall be permitted on both sides of Cotton Street and shall continue to be on both sides of South Street.
