Meeting Report**

Attendance: S. Marmarou, M. Goodman-Hinnershitz, D. Reed

Others Attending: S. Katzenmoyer

The meeting was called to order at 4:15 pm by Mr. Marmarou.

I. Interviews

Wynton Butler (appointment – Diversity Board)

Mr. Marmarou questioned how Mr. Butler learned about this vacancy and why he was interested in serving. Mr. Butler stated that he was approached to serve on this Board. He stated that he has been recruiting for additional Water Authority members.

Ms. Goodman-Hinnershitz noted the need for Mr. Butler to follow his passion.

Mr. Butler stated that the Water Authority work is time intensive. He noted his willingness to remain a member of the Water Authority until his replacement is found.

Mr. Marmarou stated that the Charter Review Commission is examining changing the Charter to allow citizens to serve in more than one capacity. Ms. Reed stated that this possibility is far in the future.

Ms. Reed expressed the belief that Mr. Butler would serve the City well as a member of the Diversity Board.

Ms. Katzenmoyer explained that the Diversity Board currently has two citizen vacancies and that the rest of the Board is composed of City staff. She stated that the Diversity Board is reorganizing.

The Committee voiced their support for Mr. Butler as a member of the Diversity Board.

Mr. Butler again stated that he does not wish to resign from the Water Authority if they will have problems reaching a quorum. He stated that he had recently learned that members of the Water Authority may reside anywhere within the service area and not only in the City. The Committee requested that Ms. Katzenmoyer confirm this with the City Solicitor.

Mr. Butler stated that Stephanie Towles would serve the City well. Ms. Katzenmoyer stated that she is a current member of the Library Board appointed by the Library. The Committee requested that Ms. Katzenmoyer consult with the City Solicitor about her ability to serve as a City appointment to an additional board.

Ms. Reed suggested that Mr. Butler be appointed to the Diversity Board when his replacement on the Water Authority is appointed.

The Nominations and Appointments Committee recommends the appointment of Wynton Butler to the Diversity Board.

Carl Herbein (reappointment – Convention Center Authority) – via telephone

Mr. Marmarou questioned how the work of the Authority was progressing. Mr. Herbein stated that the Authority has financial challenges and that it is working to break even. He stated that the Authority is looking to sell its share of the Royals and that the increase in the hotel tax will assist. He stated that there is a positive outlook.

Mr. Marmarou questioned if there will be an effect on Reading by the center opening in Allentown. Mr. Herbein stated that it will only affect Reading in a small way because of the distance to Allentown and the travel conditions on Route 222. He stated that the economy has also been an issue and that the new competition of centers in Lancaster, Allentown, Bethlehem, and the casinos has taken entertainment dollars away from Reading.

Ms. Reed questioned if the Authority has a strategic plan to address these challenges. Mr. Herbein stated that it does not have a formal strategic plan. He stated that there is a hockey subcommittee and that there is regular communication with SMG.

Ms. Goodman-Hinnershitz questioned if the Authority was involved with the City's economic development plans. Mr. Herbein stated that the Authority was involved with the Redevelopment Authority during acquisition and construction. He stated that the Authority supports DID through an annual contribution and works with the Parking Authority regarding parking revenue.

Ms. Goodman-Hinnershitz questioned if the Authority was approached about the new Community Development Corporation (CDC). Mr. Herbein stated that he has no knowledge about the CDC and referred questions to Authority Chair Ehlerman.

Ms. Goodman-Hinnershitz questioned if Mr. Herbein was willing to serve another term. Mr. Herbein stated that he is as he is committed to the City and to the centers.

The Nominations and Appointments Committee recommends the reappointment of Carl Herbein to the Convention Center Authority.

Ms. Goodman-Hinnershitz expressed her belief that the Convention Center Authority should be involved with the CDC. She suggested that they may not agree with the Mayor's plan and that this is why they were not approached. She stated that she is very concerned about the CDC and the Mayor's position that although public funds are being used that the CDC is not covered by the Sunshine Act.

Brian Miller (appointment – Plumbing Board)

Mr. Miller was not present.

Ms. Reed stated that Mr. Miller is not a resident and does not have a business or property interest in the City.

Ms. Katzenmoyer questioned if she should reschedule the interview. The Committee suggested that he be rescheduled.

II. Other Matters

- Recreation Commission

Ms. Goodman-Hinnershitz questioned if Mr. Washington applied for membership to the Recreation Commission. Ms. Katzenmoyer stated that she has not received an

application. (Note: Mr. Washington is not eligible to serve on the Recreation Commission as he has been appointed to the CRIZ Authority.)

Ms. Katzenmoyer explained that Ms. Torres will need to be replaced by the Administration and that Mr. Moran will need to be replaced by Council. She stated that Mr. Smith has submitted his application for reappointment.

- Stadium Commission

Ms. Katzenmoyer explained that the governing legislation for the Stadium Commission stated that there should be nine members. She stated that the City has only appointed seven members leaving two vacancies. She stated that the current secretary has discovered that the Commission does not have established by-laws, quorum number, etc.

Ms. Reed stated that it would be great to have a member of the Riverside community on this Commission.

The Nominations and Appointments Committee adjourned at 4:55 pm.






