**BILL NO. 67 -2015**

**AN ORDINANCE**

**LEVYING THE REAL ESTATE TAXES FOR THE FISCAL YEAR BEGINNING THE FIRST DAY OF JANUARY, 2016, AND ENDING THE THIRTY-FIRST DAY OF DECEMBER, 2016.**

**THE COUNCIL OF THE CITY OF READING HEREBY ORDAINS AS FOLLOWS:**

**SECTION 1.** For general revenue purposes, a tax of seventeen and two hundred eighty-nine thousandths mills (.017289) on the dollar, or seventeen dollars and twenty-eight point nine cents (\$17.289) on each one thousand dollars is hereby levied and assessed for the fiscal year beginning the first day of January, 2016, and ending the thirty-first day of December, 2016, on all real property in the City of Reading taxable for County purposes.

**SECTION 2.** For purposes of funding activities of the Shade Tree Commission, a tax of two-tenths mills (.0002) on the dollar, or twenty cents (\$0.20) on each one thousand dollars is hereby levied and assessed for the fiscal year beginning the first day of January, 2016, and ending the thirty-first day of December, 2016, on all real property in the City of Reading taxable for County purposes.

**SECTION 3.** For purposes of funding activities of the Reading Public Library, a tax of two-tenths mills (.0002) on the dollar, or twenty cents (\$0.20) on each one thousand dollars is hereby levied and assessed for the fiscal year beginning the first day of January, 2016, and ending the thirty-first day of December, 2016, on all real property in the City of Reading taxable for County purposes.

**SECTION 4.** All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.
