AN ORDINANCE

AUTHORIZING THE MAYOR TO EXECUTE A TEMPORARY EASEMENT FOR CONSTRUCTION PURPOSES BETWEEN THE CITY OF READING AND THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF TRANSPORTATION THEREBY CONVEYING UNTO THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF TRANSPORTATION, SAID TEMPORARY EASEMENT UPON THAT PORTION OF PREMISES SITUATE IN CUMRU TOWNSHIP, BERKS COUNTY, PENNSYLVANIA (AREA OF 0.056 ACRES ALONG STATE ROUTE 625), AS SHOWN AND DESIGNATED ON A CERTAIN PLOT PLAN ATTACHED HERETO.

WHEREAS, the City of Reading is the legal owner of real property situate along State Route 625, Cumru Township, Berks County, Pennsylvania, as shown on attached plot plan; and

WHEREAS, the City of Reading is willing to grant to the Commonwealth of Pennsylvania, Department of Transportation, a temporary construction easement in connection with a certain improvement project at said location.

NOW, THEREFORE THE COUNCIL OF THE CITY OF READING HEREBY ORDAINS AS FOLLOWS:

SECTION 1. The Mayor is authorized to execute a Temporary Easement for Construction Purposes to convey unto the Commonwealth of Pennsylvania, Department of Transportation, a temporary construction easement upon that portion of premises situate along State Route 625 in Cumru Township, Berks County, Pennsylvania with an area of 0.056 acres as shown and designated on a certain plot plan attached hereto.


SECTION 2. This Ordinance shall be effective ten (10) days after passage.


